National Commission for Indian System of Medicine, Ministry of AYUSH, Govt.of India has given direction to the State Counselling Authority to conduct the online registration and subsequent counselling for admission in All India Quota (15%) Seats of Private Unaided/ Minority Institutions for the Academic Year 2026-27.

Desirous Candidates are hereby notified to read the Instructions, Eligibility Rules and register themselves as per the schedule given below:

Note: For ensuring faithful obedience of time schedule and also keeping in view the limited time available for conducting counselling, all participating institutes/ colleges are directed to treat all Saturdays/ Sundays and Gazetted Holidays as working days.

❖ **Rules for Admission :**

1. Seats under all India Quota for Private Unaided Institute will be **OPEN** in nature. However, relaxation in qualifying criteria will be provided Category wise as per Central Government List.
2. There shall **NOT** be any requirement for Domicile Certificate in a particular State/UT or passing of 10+2 from a particular State/UT.
3. All candidates will have to produce all Original documents as mentioned in the AACCC information bulletin 2026 for AIQ seats.
4. All candidates should note that the documents related to category need to be in Central Government Format only, the State government format is not acceptable for AIQ admission process.
5. **Candidates already registered for State Counselling if desirous for admission in All India Quota (AIQ) (15%) Seats of Private Unaided Institute for BAMS/BHMS/ BUMS Courses for Academic Year 2026-27 will have to register again for All India Quota by paying Rs.2000/- Fees and Rs.50,000/- Security Deposit (as per guidelines of NCISM).**
6. State/UT Counselling Authority will conduct **03 Rounds for All India Quota Private Seats and vacant seats shall be converted into the State/UT Quota as per the instruction from Ministry of AYUSH, Government of India, New Delhi.**
7. The Security Deposit will be forfeited if a candidate does not join the allotted Seat of Round-2 or surrender/withdraw the seat allotted in Round-2 based on Candidate's request. Further, the security deposit will also be forfeited if the allotted seat of Round-2 is cancelled due to any unforeseen reason from the candidate's end. For Example, the candidate gives wrong information

at the time of registration on the basis of which a seat may be allotted and later cancelled by the Admission Authorities at the time of reporting or fails to produce the required documents at the time of admission(within the stipulated time).

8. Candidates whose fees are forfeited during CAP-2 if wish to participate in CAP-3, will have to register again by paying Registration fee and security deposit as mentioned above.
9. Other criteria will be remain same as for All India Quota seats as mentioned on AACCC official Counselling website namely "<https://aaccc.gov.in/>".
10. Candidates who are allotted seat in Both QUOTA (State Quota and All India Quota) will have to decide which Quota seat they want to join. Candidates can join seat only through ONE Quota at a time.
11. Candidates allotted and joined All India Quota Seat in Round 2 can cancel their seat up to 18/10/2026 with forfeiture of Security deposit. After which the cancellation will not be allowed under any circumstances. Candidates having Joined Status after 18/10/2026 will not be eligible for any subsequent counselling process.

❖ **Eligibility/Qualification Criteria :**

1. **HSC Passing Marks for eligibility** in admission to ASU & H, UG Courses should be as per the ASU & H, UG regulation and will be followed strictly. The details Qualifications for different categories are as follows:
 - i. The candidate shall have passed 10+2 (or equivalent) or its equivalent examination recognised by the concerned State Government and Education Board with subjects of Physics, Chemistry, Biology or Biotechnology.”
2. **NEET Passing Marks for eligibility** in order to eligible for admission to under-graduate course for an academic year, it shall be necessary for a candidate to obtain minimum of marks at 50th in NEET UG - 2026. Provided that respect of -
 - i. Candidates belonging to the Scheduled Caste, Scheduled Tribes and Other Backward Classes, the minimum marks shall be at 40th Percentile.
 - ii. candidates with benchmark disabilities specified under the Right of Persons with Disabilities Act, 2016(49 of 2016,) the minimum marks shall be at 45th Percentile in the case of General Category and 40th Percentile in the case of the Scheduled Caste, Scheduled Tribes and Other Backward Classes.
3. **Persons with Disability** candidate specified under the **Rights of Persons with Disabilities Act, 2016 (49 of 2016)**, the minimum qualifying marks in the said qualifying examination are as follows:
 - i. In Physics, Chemistry and Biology shall be **45%** in the case of **General Category. (for PwD Candidates Only)**
 - ii. **40%** in the case of the **Scheduled Castes, Scheduled Tribes and Other Backward Classes. (for PwD Candidates Only).**
 - iii. Those candidates who have marked/claimed as a PWD candidate in the Online Application, he/she has to Upload/Submit Original Certificate of Disability at the time of Registration as per the format published by Ayush Admissions Central Council Committee website namely www.aaccc.gov.in under Counselling Scheme and FAQs and State CET Cell (www.mahacet.org) website. **The Certificate should be from the list of 16 Boards as mentioned. Certificate issued by any other Board/Civil Surgeon WILL NOT be accepted.**

Besides this all coloured scanned copies of Original Necessary Documents as mentioned in the list of documents has to be Uploaded at the time of Registration Process.
