Sub: Application for letter of permission for functioning of Samarth Education Trust Sawakar Homoeopathic Medical College, A.M.1/1 Additional MIDC Degaon Road Satara- 15004 for conducting BHMS course with 100 seats for the academic year 2025-26- regd.

Sir.

Samarth Education Trust Sawakar Homoeopathic Medical College has applied for permission for sanction of BHMS course with 100 seats for the academic year 2025-26. The College has submitted the Part I information in which the entire functional profile has been narrated. MARBH conducted Inspection on 27.02.2025 & 28.02.2025, followed by hearing on 20.05.2025. The Medical Assessment and Rating Board has examined the College as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under clauses 26 and 28 of the NCH Act 2020. On careful examination of the report, the Medical Assessment and Rating Board observed the following shortfalls: -

1. Teaching faculty.

a) 01 Associate professor in department of physiology

b) 01 Assistant professor in department of Practice of Medicine.

As evident from the above statement, a total number of two teachers are deficient against the requirement of 40+1 for 100 seats UG college (As specified in MES,2024). Pursuant to F.No.:3-2/MARBH/NCH/2025-26/162-169 dated 16/04/2025 issued by MARBH, a college can avail 10% relaxation against the required number of teachers for Academic Year 2025-26 only. After allowing relaxation of 10%, college has no deficiency in teaching faculty. However, such a relaxed number of teachers may be appointed at the earliest for smooth conduct of course.

2. Miscellaneous

a) NABL accreditation for clinical laboratory not done.

- b) The salary of teaching staff and non-teaching staff is very poor and needs improvement in line of MES 2024.
- c) Form 16 is not submitted from traces portal
- 3. Considering the above observations during inspection and hearing, MARBH has decided to issue Conditional Permission to Samarth Education Trust Sawakar Homoeopathic Medical College, A.M.1/1 Additional MIDC Degaon Road Satara- 15004 for conducting BHMS course with 100 seats for academic year 2025-26 on the basis of following condition:
 - a) NABL accreditation for clinical laboratory to be done at the earliest.
 - b) The salary of the staff should be as per the criteria mentioned in MES 2024.
 - c) Submit Form 16 from traces portal for all staff.

- 4. All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity of 100 UG seats shall be treated as All India Quota. Counseling for seats under all India quotas shall be conducted by respective Counseling Authority of State/UT govt as designated by Central Government and counseling for the remaining 85% seats or, shall be conducted by the concerned counseling authority of the state/UT.
- 5. The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.
- Conditions under point 3 should be fulfilled within a period of one month and the compliance report shall be submitted for verification to the office, failing which permission for the academic year 2025-26 may be withdrawn.
