Sir/Madam,

Samarth Education Trust's Sawarkar Homoeopathic Medical College has submitted an application for permission of 100 seats in BHMS course for the academic year 2026-27. The Medical Assessment and Rating Board (MARBH), examined special application proforma submitted by the college followed by hearing on 08/04/2026. MARBH has examined the College to ascertain whether the college fulfils the Minimum Essential Standards as per the regulations in force. On careful examination of the report, MARBH observed the following shortfalls:

- A. Salary of teaching, non teaching and hospital staff is not as per MES 2024.
2. Considering the above observations during hearing, MARBH has decided to issue **Conditional permission to Samarth Education Trust's Sawarkar Homoeopathic Medical College for admission in BHMS course with intake Capacity of 100 seats for the academic year 2026-27 on the basis of following conditions:**
 - i. Salary of staff should be as per first schedule of National Commission for Homoeopathy (Minimum Essential Standards for Homoeopathic Colleges and Attached Hospitals Regulations, 2024).
3. All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity of UG seats shall be treated as All India Quota. Counselling for seats under all India Quota shall be conducted by respective Counselling Authority of State/UT Government as designated by Central Government and counselling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counselling authority of the State/UT.

4. The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board
