AND WHEREAS the super specialty hospital running by party no. 2 having facilities of Operation Theater, labour room, intensive care unit, USG machine and other required facilities for management of critical patients.

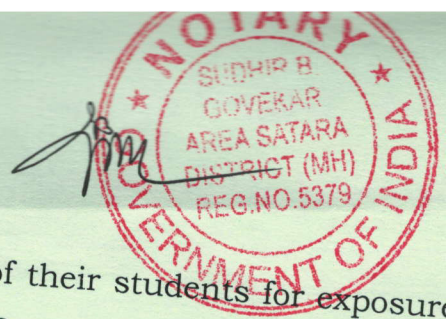
AND WHEREAS the party no. 1 approached to party no. 2 and given the proposal to attach the said hospital to their college for exposure of students in a clinical field.

Now this Memorandum of understanding witnessth as follows:

1. That the present understanding is for exposure of the students of party no. 1 in a clinical field and to understand the depth of operative surgery and operative gynecology or obstetrics as well as management in critical illness and use of USG machine.
2. That the hospital of party no. 2 having 70 beds so also having facilities of Operation Theater, labour room, intensive care unit





3. That the party no. 1 provide list of their students for exposure in the said field in advance to the Party no.2.
4. That the students of party no. 1 deputed to hospital of party no. 2 are under the strict supervision of the teachers of the party no. 1
5. The students which are deputed by party no. 1 in the hospital of Party no.2 be allowed to enter in the hospital premises. So also operation theaters, labour room, use of USG machine and management critical patients as per the requirement of party no. 2.
6. That the students of the party no. 1 and the teachers who are deputed for supervision shall obey the instructions of partners of the party no. 2. So also students should obey the disciplines, rules and regulations of the hospital.
7. Party no. 2 agreed to provide exposure to the students of party no. 1 in a clinical field without any monitory charges.
8. That the present understanding is remain in force till the willingness of both the parties and the understanding commencing from the date of 01/04/2013.
9. That the party no. 1 can use good will of hospital of party no. 2 for exposure of students.

As per regulation of Homoeopathy Central (Minimum Standard of Requirement of Homoeopathic Colleges and Hospital) Regulations 1983 (as amended upto September 2002). Central Council of Homoeopathy, Notification, New Delhi, the 8th March, 2013 & Homoeopathy (Degree Course) B.H.M.S. Regulations, 1983 (As amended upto March, 2016).

As per regulation Central Council Of Homoeopathy, Notification, New Delhi, the 8th March 2013, clause 3(2), for exposure of the students in the clinical field & to understand the depth of operative surgery and operative Gynecology or Obstetrics as well as management in critical illnesses, it college shall have a memorandum of Understanding with a reputed hereby located super-specialty hospital (of modern medicine) with all required facilities of operation theatre, labour room, Intensive Care Unit and other required facilities for the management of critical patients, And Homoeopathy (Degree Course) B.H.M.S. Regulations 1983 (As Amended upto March 2016) instruction IV©, In syllabus of subject of Practice of Medicine he shall be trained as a sound clinician with adequate ability of differentiation, sharp observation and conceptual clarity about disease by taking help of all latest diagnostic techniques, X-ray, ultrasound, electrocardiogram and commonly performed laboratory investigations.

Dr.Mrs.Mahananda V.Shete, Nandadeep Hospital Satara has given permission of USG for adequate ability of differentiation, sharp observation and conceptual clarity about diseases for Sonography to the SET'S Sawkar Homoeopathic Medical College & Samarth Hospital Additional M.I.D.C Degaon Road Satara under the strict supervision for concerned teaching faculty of the college. This memorandum of understanding is done by mutual understanding of both parties. Also this MoU is made between us for utilizing the sonography machine of Nandadeep Hospital Satara.



Second party agrees to provide USG investigation facility to the patients of First party under following terms & conditions.

1. USG investigations will be performed to the patients who are duty referred from college hospital, first party and signed by the medical officer/ specialty Doctor of college hospital, second party.
2. Patient has to pay the investigations charges fix by second party hospital before leaving hospital.
3. The first party hospital authorities will help to maintain second party hospitals rules & regulation/discipline.
4. If any damage/breakage of equipment is reported during procedure recovery will be recovered by concern operator who was operating the equipment.
5. The present understanding will remain in force till the willingness of both the parties and the understanding commencing from the date of 3/8/2018
