PARTY OF THE SECOND PART

WHEREAS the party of the first part is registered as per the provisions of Bombay public Trust 1950 and same trust is running the medical college known as S.E. T's Sawkar Homoeopathic Medical Collage.



AND WHEREAS the National Commission for Homoeopathy has to granted permission to B.H.M.S course to party no. 1. The Maharashtra University of Health Sciences Nashik duly granted continuation of affiliation to B.H.M.S. Course to the party no.1. As well as the Government of Maharashtra has also given the recognition for undergraduate homoeopathic medical college.

AND WHEREAS the party of the second party is registered partnership firm running super specialty hospital in the name and style of Shri Mangalmurti Clinic & Research Centre Pvt. Ltd., Kalyani Estate, Opp. ZP, Satara. The said hospital is duly registered by National Accreditation Board for Hospitals & Healthcare Providers (Constituent Board of Quality Council of India) and it's Certificate No. PESHCO-2023-7731. So also the said hospital is duly registered on 18/04/2023 under Constituent Board of Quality Council of India. The registration certificate is duly issued by Swargiya Krantiveer Nana Saheb Patil General Hospital, Satara & which is renewed from time to time.

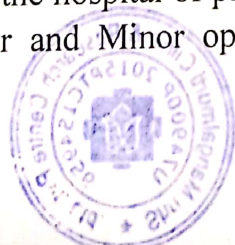
AND WHEREAS National Commission for Homoeopathy (Minimum Standards Requirements of Homoeopathic Colleges And Attached Hospitals) Regulation 2024 comes in to enforcement. Hence, as per the said regulations for the exposure of students in a clinical field and to understand the depth of operative surgery and operative gynecology or obstetrics as well as management in critical illness and use of USG machine party no.1 searching for super specialty hospital.

AND WHEREAS the party no.1 approached to party no.2 and given the proposal to attach the said hospital to their college for exposure of students in a clinical field.

AND WHEREAS after the discussion and negotiation the parties arrived at understanding which are reduced in writing as follows:

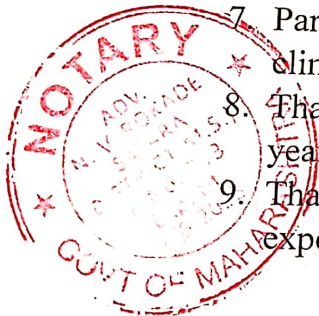
Now this Memorandum of understanding witness as follows:

1. That the present understanding is for exposure of the students of party no.1 in a clinical field and understand the depth of operative surgery as well as management in critical illness.
2. That the hospital of party no.2 having 30 beds so also having facilities of Major and Minor operation theatre, Intensive Care Unit, Philips Flat



panel Cardiac Cathlab, Dialysis, Surgical ICU, Medical ICU, Cardiology and Cathlab procedures, Neurology, Nephrology and Dialysis, Laproscopic and General Surgery, Orthopedics, All types of Surgeries in Modular, Operation Theatre, Digital X-Ray, 2 D Echo, Intensive Care Unit (Medical & Surgical), Semi ICU and other required facilities, and other required facilities for management critical patients.

3. That the party no.1 shall provide list of their students for exposure in the said field in advance to the party no.2
4. That the students of party no.1 deputed to hospital of party no. 2 are under the strict supervision of the teachers of party no. 1
5. The students which are deputed by party no.1 in the hospital of party no. 2 be allowed to enter in the hospital premises. So also operation theaters, and management of critical patients as per the requirement by party No. 2.
6. That the students of the party no. 1 and the teachers who are deputed for supervision shall obey the instructions of partners of the party no. 2. So also, students should obey the disciplines, rules and regulations of the hospital.
7. Party no.2 agreed to provide exposure to the students of party no. 1 in a clinical field without any monitory charges.
8. That the present understanding will remain in force for the period of two years (24 months) commencing from the date of 01/01/2025
9. That the party no. 1 can use good will of hospital of party no. 2 for exposure of students.
