## Extended Online Registration Process for Health Science Courses [MBBS/BDS/BAMS/BHMS/BUMS/BPTH/BOTH/BASLP/B (P&O)]

In view of the technical glitches and other issues faced by the aspiring candidates and request from candidates for extension in registration process for NEET-UG-2023 centralized admission process, the Competent Authority has decided to extend the date of registration for MBBS/BDS course. In addition, those candidates who want to apply only for AYUSH and/or allied courses can register themselves in phase 2 of registration as per the schedule given in Table 2.
